Outside Food Policy

- Only commercially produced food or factory sealed items may be brought onboard*
- All food must come on prepared platters with any required serving utensils.
- Limitations on food include but is not limited to**:
 - No wet sauces or sauces that cause permanent stains (soy, blueberry, tomato etc....)
 - No leafy or light weight foods that can blow away.
 - No custom cakes above 5" tall We recommend cupcakes
- Individual plated food is not recommended.
- No plastic straws are permitted on any yacht.
- **All menu items must be pre-approved by Gone Sailing Adventures in advance of your sail.
- Galley fee includes:

Napkins/plates/individual cutlery, serving and cleaning.

*Due to the potential food contamination by allergens/bacteria/recreational drugs
No home-prepared food is permitted.

No outside food is permitted on public shared sails.

Liquor Licence Act

R.R.O. 1990,

Excerpt

Section 31(2)

- (2) No person shall have or consume liquor in any place other than,
 - (a) a residence;
 - (b) premises in respect of which a licence or permit is issued;
 - (c) a private place as defined in the regulations; or

REGULATION 718

- 3. (1) For the purposes of clauses 30 (13) (a) and 31 (2) (c) of the Act, "private place" means a place, vehicle or boat described in this section. R.R.O. 1990, Reg. 718, s. 3 (1).
- (7) A boat with permanent sleeping accommodations and permanent cooking and sanitary facilities, other than a boat used to carry passengers for hire is considered to be a private place while the boat is at anchor or is secured to the dock or land. R.R.O. 1990, Reg. 718, s. 3 (7).
- (9) A boat that is used exclusively to carry passengers for hire and has sleeping accommodation for all passengers is considered to be a private place if it is under the command of a person certified under the O. Reg. 246/16, s. 1.

**Gone Sailing Adventure's Yachts meet the requirements for Section 9.
